Please complete this form and sign it to make your Notice-To-Vacate (NTV) official. If you have a question about the information below, please reach out to your Portfolio Manager for clarity.

Per Section 18 of your Apartment Lease Contract, *"To terminate the month-to-month tenancy, the party desiring to terminate must give to the other party written notice at least 60 days prior to the proposed date of termination."* If you have not given a proper 60 day notice, your ledger will be charged rent for the time commencing on the day you submitted notice for 60 days. Section 18 of your Lease also states, *"All notices of lessee hereunder must be in writing and must be countersigned by a representative of lessor to be valid. No verbal notices shall be accepted or binding."* Once you have signed this form, our representative will countersign it and then process it. At that time, the NTV becomes official. You will be able to access a copy of it in your TWA.

CAREFULLY SELECT YOUR MOVEOUT DATE

Vesica Real Estate will use the move-out date you provide to market your unit and secure a new resident. Please select your date carefully. The date you select must be one day prior to a business day so that staff can confirm you are out by the date you indicate. If you select a date prior to a weekend or holiday, we will schedule your move-out for midnight on a day prior to a business day. You must be out on the date you provide, else incur fines and possible legal action for a holdover. Please initial to acknowledge you have read this entire section.
